### Information/Registration

#### Intended audience:

CAS arbitrators, counsel and lawyers who operate in the areas of arbitration and sports law, representatives of associations or federations, in-house counsel to companies in the «sport business» whose contracts or bylaws provide for the resolution of any disputes by arbitration before the CAS.

#### Purpose of the seminar:

The first part of the first day will cover topics of great practical importance, such as the new developments in Gender policies issues or the exploitation of digital rights in professional football. During the second part of the first day, the speakers will focus from different perspectives on current trends and recent case law in sports-related disputes, with a specific focus on Athlete rights and Football Disciplinary cases.

Traditionally, the second day will be dedicated to a review of CAS jurisprudence in the field of international football. There will not only be reviews of the case-law, but there will also be a presentation of the latest developments relating to the FIFA Rules and Regulations.

#### Place:

The conference will take place at the Hotel Beau-Rivage Palace, Lausanne.

#### Language:

The lectures will be held in English without simultaneous translation.

#### **Conditions of registration:**

The registration fee for the seminar in the **Main Room** is CHF 730.00 for members of the FSA/SAV and of the CAS and CHF 920.00 for all other participants.
